It is clarified that the values/details given in the brochure hosted on website www.cngpetrolpumpdealership.com and as noted below will be applicable for selection for CNG Petrol Pump Dealership 2025.

### 1. Land (Applicable to all categories):

The applicants would be classified into three groups as mentioned below based on the land offered or land not offered by them in the application form:-

- a. **Group 1**: Applicants having suitable piece of land in the advertised location/area either by way of ownership / long term lease for a period of minimum 10 years 11 months or as advertised by the Companies.
- b. **Group 2:** Applicants having firm offer for a suitable piece of land for purchase or long term lease for a period of minimum 10 years 11 months or as advertised by the Companies.
